
## THE NOAH JAMES FOUNDATION AGREES TO DO THE FOLLOWING:

- Give the Adopter title to, possession and control of the dog as described: For so long s the ADOPTER complies with the terms of this contract. All liability due to property damage or personal injury, accident or illness will be transferred to the new owner upon adoption.
- 2. Provide ADOPTER with any all veterinary records available for dog along with current medications
- 3. RESCUER acknowledges receipt from ADOPTER of a donation as noted below to aid with reimbursement of expenses incurred to consider dog for adoption.

Please do not expect our or any other rescue to be able to take your animal immediately. We will also recommend a training program at your expense, fitting to your animal before the consideration of accepting them back into rescue if behavioral issues are noted. |
